MINUTE ORDER: The parties last appeared before the court on July 7, 2021, and the Pretrial Services Agency last filed Pretrial Compliance Reports as to both Defendants on July 5 and 6, 2021. Following the July hearing, the parties moved to continue their September 29, 2021, status conference. The court granted their motion and continued the status conference until December 15, 2021. As that hearing approached, the parties again moved for a continuance. The court granted the second continuance and set a status conference for March 4, 2022, but noted that given the length of the present continuance, there will not be any further continuances absent extraordinary circumstances. See Min. Order (Dec. 14, 2021). Defendant Cortez now moves to continue the March 4 hearing, contending that additional time is needed to review discovery, prepare pretrial motions, and negotiate with the government regarding possible disposition. However, counsels' ability to review discovery materials, prepare pretrial motions, and negotiate with the government, and its ability to provide an update for the court on discovery and Defendants' compliance with pretrial conditions of release, are not mutually exclusive. Moreover, the court is responsible for managing its docket efficiently and effectively to ensure prompt and fair disposition of this case. Given the length of time since the last status conference and Pretrial Compliance Reports, the court finds that maintaining the currently scheduled March 4, 2022, status conference aligns with the interests of justice.
