Counsel for Defendant advised the Court that Defendant desires to waive his identity and preliminary hearings, reserving his right to have his preliminary hearing in the charging district.

Defendant placed under oath and questioned regarding waiving such rights. Waiver of Rule 5(c)(3) Hearings executed in open court.

The Court finds that Defendant knowingly, intentionally, voluntarily and freely waived his right to an identity hearing. **Order to enter.**


**WAIVER OF RULE 5(c)(3) HEARINGS**


I, DANA JOE WINN, understand that charges are pending in the District of Columbia alleging violations of 18 U.S.C. § 1752(a)(1)-(2) and 40 U.S.C. § 5104 (e)(2)(D)(G) and that I have been arrested in this district and taken before a United States magistrate judge, who informed me of the charges and my rights to:

- (1) retain counsel or request the assignment of counsel if I am unable to retain counsel;
- (2) an identity hearing to determine whether I am the person named in the Indictment;
- (3) a preliminary hearing (unless an indictment has been returned or information filed) to determine whether there is probable cause to believe an offense has been committed by me, the hearing to be held in this district or the district of prosecution; and
- (4) request transfer of the proceedings to this district under Rule 20, Fed. R. Crim. P., in order to plead guilty.

**I HEREBY WAIVE (GIVE UP) MY RIGHT TO A(N):**

- identity hearing
- preliminary hearing
- Identity hearing and have been informed I have no right to a preliminary hearing
- Identity hearing and reserve my right to have the detention hearing held in the prosecuting district
- identity hearing but request a preliminary hearing to be held in the prosecuting district and, therefore, consent to the issuance of an order requiring my appearance in the prosecuting district where the charges are pending against me.

**ORDER**
