DEFENDANT'S UNOPPOSED MOTION TO CONTINUE STATUS HEARING and
WAIVER of RIGHTS UNDER THE SPEEDY TRIAL ACT

Mr. Sidorski, through undersigned counsel, respectfully moves this Court to continue his status hearing currently scheduled for May 3, 2021. In support of this motion counsel states:

1. Ms. Sidorski is before the Court charged with unlawfully entering a restricted building and other offenses stemming from the events of January 6, 2021.
2. On April 27, 2021, the government provided some preliminary discovery and promised to provide additional discovery.
3. In the time remaining prior to May 3, 2021, it will not be possible for counsel to meet with Mr. Sidorski to review even the discovery currently provided. With additional discovery forthcoming, there would have been a request at any rate on May 3, 2021, for a continuance to review the additional discovery.
4. Undersigned counsel and assigned AUSA Jeffrey Poulin have discussed the matter and agree that a 3-4 week continuance is appropriate under the circumstances. Thus the government does not oppose the instant motion.
5. Mr. Sidorski, having been advised of his rights pursuant to the Speedy Trial Act, 18 U.S.C. §3161, and aware of the need to continue the status hearing currently set on May 3, 2021, hereby consents to the exclusion of time pursuant to the

Speedy Trial Act, 18 U.S.C. 213161, between the dates of May 3, 2021, and the date which the Court selects for the next status hearing.

WHEREFORE, undersigned counsel respectfully requests that this Honorable Court reschedule the status hearing to a date 3-4 weeks away convenient to the Court and parties.
