All of the exhibits are exhibits that were admitted in the trial of defendant Dustin Thompson before this Court, and are numbered according to their trial exhibit number. The exhibits are:

1. Trial Exhibit 123 is a video approximately 37 seconds in length, taken by Dustin Thompson inside the Senate Parliamentarian’s office. It must be played used Windows Media Player, not VLC media player.
2. Trial Exhibit 201C is a CCTV video approximately 1 minute and 57 seconds in length depicting rioters breaking and entering into the Capitol building next to the Senate Parliamentarian’s office.
3. Trial Exhibit 231A is an open-source video approximately 27 seconds in length depicting rioters in the courtyard outside the Senate Parliamentarian’s office around 2:47 p.m.
4. Trial Exhibit 235 is an open-source video approximately 3 minutes and 6 seconds in

length depicting rioters attempting to breach the North Doors of the Capitol building at around 4 p.m.

5. Trial Exhibit 240A is an open-source video approximately 1 minute and 22 seconds in length depicting rioters attempting to breach the lower west tunnel entrance to the Capitol building between around 4:40 p.m. and 5:05 p.m. The video includes Dustin Thompson.
6. Trial Exhibit 242A is an open-source video approximately 1 minute and 35 seconds in length depicting rioters attempting to breach the lower west tunnel entrance to the Capitol building between around 4:40 p.m. and 5:05 p.m. The video includes Dustin Thompson.
7. Trial Exhibit 245A is an open-source video approximately 2 minutes and 59 seconds in length depicting rioters attempting to breach the lower west tunnel entrance to the Capitol building between around 4:40 p.m. and 5:05 p.m. The video includes Dustin Thompson.
8. Trial Exhibit 246A is an open-source video approximately 1 minute and 25 seconds in length depicting rioters attempting to breach the lower west tunnel entrance to the Capitol building between around 4:40 p.m. and 5:05 p.m. The video includes Dustin Thompson.
9. Trial Exhibit 248 is an open-source video approximately 1 minute and 2 seconds in length depicting rioters breaching the Capitol building next to the Senate Parliamentarian's office around 2:45 p.m.
10. Trial Exhibit 287 is an open-source video approximately 25 seconds in length depicting the damage to the Senate Parliamentarian's office from the rioters on January 6, 2021.
