Meriweather. It is further ORDERED that the time period between September 3, 2021 through November 2, 2021 is hereby excluded from the computation of time within which an information must be filed under the Speedy Trial Act, 18 U.S.C. § 3161, et seq. The Court finds that the ends of justice served by the granting of such continuance outweigh the best interest of the public and the defendant in a speedy trial, as the continuance will provide the parties with additional time to gather and review the
