In light of these representations, the ongoing discovery in this matter, and the need for new counsel for the Defendant to review the evidence and consult with his client, the Court finds that the ends of justice served by the continuance outweigh the best interest of the public and the defendant in a speedy trial under 18 U.S.C. 3161(h)(7)(A).
