- 7. According to the email sent to defense counsel, "[p[hotos are allowed only in the public areas" and the officers leading the walkthroughs "are not there to answer specific questions about your cases but can answer general questions." See Ex. 4, email from Emily Miller, April 27, 2022.
- 8. Given the government's arbitrary and inflexible position regarding access to these areas, defendant Wood respectfully requests he be given access to these non-public areas of the Capitol for the purpose of photographing, measuring and viewing them to prepare for his defense and trial in this matter.
