**GOVERNMENT’S NOTICE OF FILING OF EXHIBITS PURSUANT
TO LOCAL CRIMINAL RULE 49 AND STANDING ORDER 21-28**

The United States hereby gives notice, pursuant to Local Criminal Rule 49 and Standing Order 21-28, of the following exhibits are provided to the Court and counsel to be used by the government in the sentencing in this matter. Exhibits 29-33, 36 were obtained from the telephone of the Defendant. Exhibit 34 is a clip from a video of another January 6th defendant. Exhibit 35 is United States Capitol Police surveillance footage (CCTV). The United States does not object to releasing these exhibits to the public. The exhibits are:

1. Government Exhibit 29 is a video approximately 28 seconds in length that portrays the West Lawn of the Capitol, by the northwest stairs.
2. Government Exhibit 30 is a video approximately 13 seconds in length that portrays rioters climbing scaffolding and the northwest stairs to the Upper West Terrace area.
3. Government Exhibit 31 is a video approximately 12 seconds in length that portrays the West Lawn of the Capitol from a distance, with smoke in the air.
4. Government Exhibit 32 is a video approximately 16 seconds in length that depicts rioters and police officers below and on the Upper West Terrace area.
5. Government Exhibit 33 is a video approximately 12 seconds in length depicting Defendant’s walk down the hallway leading to the Crypt.

6. Government Exhibit 34 is a video approximately 21 seconds in length depicting Defendant walking down the hall, closer to the Crypt.
7. Government Exhibit 35 is a USCP CCTV video approximately 1 minute 24 seconds in length depicting the surge in the Crypt against police at approximately 2:24 p.m. on January 6, 2021.
8. Government Exhibit 36 is a video approximately 45 seconds in length depicting Defendant turning a corner and going toward the Speaker's Lobby Doors.
