

Conduct in a Capitol Building; and 7) 40 U.S.C. § 5104(d), Stepping, Climbing, Removing, or Injuring Property on the Capitol Grounds.

2. The government alleges that Mr. Faulkner damaged a particular window on the exterior of the U.S. Capitol. Despite the fact the window is on the exterior of the U.S. Capitol, upon information provided by the government, the allegedly damaged window is not in an area that can be accessed by the general public. Accordingly, to see the damage, counsel is required to take a guided tour while Congress is not in session coordinated through the U.S. Attorney's Office in order to visit the crime scene of the U.S. Capitol.

3. On August 14, 2021, the parties had arranged for counsel to defendant to take a tour of the U.S. Capitol. Unfortunately, counsel for defendant had an unexpected death in the family and could not attend the tour.

4. Per the government's understanding, there will be another tour of the U.S. Capitol in about 3-4 weeks. Undersigned counsel will plan to attend the tour.

5. It is expected that viewing the scene will be helpful to the parties for further plea negotiations and/or trial preparation. The parties are still hopeful that a plea agreement can be reached. Mr. Faulkner agrees to exclude the time from now until the next status date under the Speedy Trial Act.

6. Accordingly, the parties request for the status hearing to be continued for approximately sixty (60) days, to approximately the first week in December, 2021.

WHEREFORE, the parties jointly request for the status in this matter to be continued for sixty (60) days.
