## DEFENDANT'S UNOPPOSED MOTION TO EXTEND REPLY DEADLINE

COMES NOW, Defendant, William McCall Calhoun, Jr., by and through undersigned counsel, and without opposition of the Assistant United States Attorney, and herby files this motion to extend the reply deadline to the Government's response to Defendant's Motion in Limine (ECF Numbers 121 and 124). Counsel for the United States does not oppose the relief requested in this Motion.

Since receipt of the Government's response on September 26, 2022, counsel for Defendant has not had adequate time to speak with Defendant regarding the reply, nor had adequate time to even write the reply.
