Mr. Stevens is charged in Count 36 with disorderly and disruptive conduct in a restricted building or grounds with a deadly weapon, in violation of 18 U.S.C. §§ 1752(a)(2) and (b)(1)(A), and in Count 44 and with engaging in physical violence in a restricted building or grounds with a deadly or dangerous weapon, in violation of 18 U.S.C. §§ 1752(a)(4) and (b)(1)(A).
