11 **CONSENT MOTION TO CONTINUE STATUS HEARING**

13 Defendant, Anthime Gionet, through counsel, respectfully requests this Court to
14 continue the status hearing currently set for June 25, 2021. Defendant also agrees to exclude
15 time under the Speedy Trial Act. The parties are requesting the status hearing to be reset out
16 between 30 to 60 days with the preference of both parties being the latter.

18 The parties are continuing to confer for potential pretrial resolution. Additionally,
19 counsel for Defendant has a conflict for the June 25, 2021, hearing date. Also, some discovery
20 has been disclosed, however, counsel for Defendant has had troubles accessing the governments
21 portal and the parties are attempting to resolve that issue. There remains a great deal of
22 discovery yet to be disclosed.

24 The additional time is needed to work out the above-mentioned issues and Defendant
25 submits that the ends of justice are served by additional time requested. Counsel for the
26 government has submitted that the governments unavailable dates would include July 16, 30
27 and August 13. Therefore, we respectfully request this Court reset this matter for 30 to 60 days.
