**GOVERNMENT’S NOTICE OF FILING OF SENTENCING EXHIBITS**

The United States hereby gives notice, pursuant to Local Criminal Rule 49, of the following exhibits that were provided to the Court and defense counsel in relation to the Government’s Sentencing Memorandum (ECF No. 35):

1. Exhibit 1: A five-minute and 26-second clip of U.S. Capitol Police (“USCP”) closed-circuit video (“CCV”) footage from January 6, 2021, depicting the breach of the East Rotunda Doors at approximately 2:38 p.m. EST. The defendant enters the screen at time stamp 00:37.

2. Exhibit 2: A three-minute and 42-second clip of USCP CCV footage from January 6, 2021, depicting the breach of the East Rotunda Doors at approximately 2:38 p.m. EST. The defendant can be seen throughout the entire video.

3. Exhibit 3: A five-minute and nine-second clip of USCP CCV footage from January 6, 2021, depicting the breach of the East Rotunda Doors at approximately 2:38 p.m. EST. The defendant is not visible in this video because he was standing behind the marble pillar on the left side of the screen.

4. Exhibit 4: A five-minute and 48-second video obtained, pursuant to a search warrant, from defendant Ronald Sandlin’s computer. *United States v. Ronald Sandlin, et al.*, :21-

cr-88 (DLF). The video depicts the breach of the East Rotunda Doors at approximately 2:38 p.m. EST, as well as the initial breach of the Senate Gallery.
