**GOVERNMENT’S NOTICE OF FILING OF EXHIBITS**  
**PURSUANT TO LOCAL CRIMINAL RULE 49**

The United States of America, through the undersigned, hereby gives this notice pursuant to Local Criminal Rule 49, of the following exhibits that were provided to the Court and defense counsel on April 29, 2022 via USAfx, in relation to the Government’s Motion in Limine Regarding Authentication of Photographic and Video Evidence. Because the exhibits are video clips, they are not in a format that readily permits electronic filing on CM/ECF.

The proposed exhibits are as follows:

1. Government Exhibit 1 is a ten-second video filmed by a Bloomberg/Getty photographer inside the United States Capitol on January 6. The video, filmed from the Small Senate Rotunda, depicts defendant Joshua Pruitt throwing a sign in an area near the Old Supreme Court.

2. Government Exhibit 2 is a 19-second video posted by Matt Laslo to social media. The video depicts Pruitt jumping over a barrier and advancing toward the Senate Wing Door to the U.S. Capitol on January 6, 2021.

3. Government Exhibit 3 is a 12-second video from Elijah Schaffer depicting rioters and U.S. Capitol Police in the Crypt on January 6, 2021.

4. Government Exhibit 4 is a 61-second video obtained from the cell phone of Chance Uptmore depicting the northwest lawn area of the Capitol and the breach of the stairs leading to the Upper West Terrace.

5. Government Exhibit 5 is a 36-second video of Pruitt's initiation into the Proud Boys on November 14, 2020. It was posted by Brendan Gutenschwager.

If the Court accepts these proposed exhibits into evidence, the United States takes the position that the entered exhibits should be promptly released to the public.
