**UNOPPOSED MOTION TO
CONTINUE THE JULY 1, 2022,
STATUS HEARING AND TO
EXCLUDE TIME UNDER THE
SPEEDY TRIAL ACT**

COMES NOW, Jared Hunter Adams, through counsel, and hereby moves this Court to continue the July 1, 2022 Status Hearing to September 5, 2022, or thereafter, convenient to all parties, and further to exclude the time within which the trial must commence under the Speedy Trial Act, 18 U.S.C. § 3161 et seq., on the basis that the ends of justice served by taking such actions outweigh the best interest of the public and the defendant in a speedy trial pursuant to the factors described in 18 U.S.C. § 3161(h)(7)(A), (B)(i), (ii), and (iv). In support of its motion counsel would state:

1. The defendant is charged by Information with misdemeanor offenses related to crimes that occurred at the United States Capitol on January 6, 2021.
2. A Status Hearing is set for July 1, 2022.
3. Counsel and the defendant are still reviewing the extensive discovery in this matter.
