NOTICE OF FILING

The United States of America, by and through its attorney, the United States Attorney for the District of Columbia, hereby notifies the Court of the submission of video exhibits in support of sentencing in the above-captioned matter. Video exhibits have been submitted to the Court and made available to defense counsel via the government’s file-sharing site, USAfx. Video exhibits will also be made available to the public consistent with Standing Order 21-28 issued by the Chief Judge on May 14, 2021. Each exhibit is briefly identified and described below:

- Exhibit 8: Publicly available video posted to Youtube¹ showing Creek’s assault of Sgt. J.C.M. and Creek throwing an object that appears to be a ratchet strap. (Video length: 1 minute, 31 seconds.) Also submitted are two edited versions of Exhibit 8, as labeled and described below:
 - Exhibit 8 with indicator box.mp4 – Exhibit 8 at regular speed, including a red box highlighting the defendant
 - Exhibit 8 slow.mp4 – Exhibit 8, including a red box highlighting the defendant, at 50% speed
- Exhibit 9: Publicly available video archived from social media site Parler² showing the end of Creek’s assault of Sgt. J.C.M., Creek’s assault of Officer R.S.E., and Creek throwing an object that appears to be a ratchet strap. (Video length: 2
