CONSENT MOTION TO CONTINUE STATUS CONFERENCE  
AND EXCLUDE TIME UNDER THE SPEEDY TRIAL ACT

Defendant Corinne Montoni, through undersigned counsel, hereby files this motion to adjourn the status conference set for Tuesday April 4, 2023 in the above-captioned matter, for approximately 2 ½ weeks, until April 21, 2023 (or a subsequent date suitable to the Court and counsel). Government counsel concurs in this motion. The parties request the additional time to engage in plea negotiations and review ongoing discovery productions.

The parties further request that the Court exclude the time until the status conference on April 21, 2023, pursuant to 18 U.S.C. § 3161 *et seq.*, on the basis that the ends of justice served by taking such actions outweigh the best interest of the public and the defendant in a speedy trial pursuant to the factors described in 18 U.S.C. § 3161(h)(7)(A).

The Court finds that the ends of justice served by the granting of such a continuance outweighs the best interests of the public and the defendant in a speedy trial, as a continuance will provide the parties additional time to continue negotiating a potential pretrial resolution and afford the parties additional time to review discovery.
