**GOVERNMENT’S NOTICE OF FILING OF EXHIBITS PURSUANT
TO LOCAL CRIMINAL RULE 49 AND STANDING ORDER 21-28**

The United States hereby gives notice, pursuant to Local Criminal Rule 49 and Standing Order 21-28, of the following exhibits are provided to the Court and counsel to be used by the government in the sentencing in this matter. The six (6) exhibits are videos taken by Chance Uptmore on January 6, 2021. The United States does not object to releasing these exhibits to the public. The exhibits are:

1. Government Exhibit 159 is a video clip approximately 1:45 minutes in length and portrays part of the former President’s speech January 6, 2021 at the Ellipse in Washington, D.C.
2. Government Exhibit 186 is a video approximately 49 seconds in length that portrays rioters on the west front and officers at the top the Northwest stairs, motioning to rioters to stay back, while rioters are chanting and yelling “commies”.
3. Government Exhibit 212 is a video 1:01 minutes in length and it portrays the rioters farther up the stairs and the officers being overrun by the mob , that then goes up the Northwest stairs to the Upper West Terrace.
4. Government Exhibit 227 is a video approximately 7 seconds in length that depicts the rioters and alarm blaring as officers try to keep the mob outside the Capitol at the Upper

West Terrace door.

5. Government Exhibit 234 is a video clip of approximately 53 seconds in length that depicts the defendant James Uptmore and others. Rioter's chant and yell at law enforcement officers at the door leading to the Senate in the Old Senate Chamber hallway.
6. Government Exhibit 12D60 is a video clip of approximately 14 seconds in length that depicts the rioters being sprayed with a chemical by law enforcement officers holding the line, as the mob tried to gain access to the Senate area through the Old Senate Chamber hallway.
