## AMENDED SCHEDULING ORDER

On June 19, 2022, the Court set forth the schedule for pretrial motions and trial, which is scheduled to begin with jury selection on April 17, 2023. See Scheduling Order [Dkt. No. 65]. The scheduling order directed the parties to meet and confer and propose further dates for the exchange of case-in-chief exhibits, exhibit lists, and witness lists; the submission of proposed jury instructions and a jury verdict form; and proposed dates for oral arguments on all pretrial motions—including Rule 12 motions, motions in limine, and Daubert motions—and a final pretrial conference. See id. at 2. On August 1, 2022, the parties filed a joint status report with most of the requested information. See August 1, 2022 Joint Status Report ("JSR") [Dkt. No. 67]. The Court adopts the parties proposed additional dates, with the exception of the date for oral argument on Rule 12 motions, motions in limine, and Daubert motions, which will be held on March 13, 2023, beginning at 10:00 a.m. The Court also sets a date for the submission of proposed jury instructions and a jury verdict form. Accordingly, it is hereby

ORDERED that the Court's Scheduling Order [Dkt. No. 65] is modified by this Order, as set forth in the following schedule:

April 11, 2023	The parties shall exchange proposed case-in-chief exhibits and witness lists. The parties may submit any additional exhibits for admission at trial if they are provided to counsel for review the day that the exhibits are submitted for admission.	
April 13, 2023 at 1:00 p.m.	Final pretrial conference in Courtroom 29.	
April 17, 2023 at 10:00 a.m.	Jury selection will commence in the Ceremonial Courtroom (Courtroom 20) in the E. Barrett Prettyman Courthouse.	
April 18, 2023 at 10:00 a.m.	Trial will commence in Courtroom 29 with opening statements, and will continue each weekday at 10:00 a.m. until concluded.
