MOTION TO MODIFY CONDITIONS OF RELEASE

This past week marked three months of Clayton Mullins being in full compliance with the Court's Order Setting Conditions of Release (ECF No. 11; 21-mj-233-RMM; issued by Chief Judge Howell on March 2, 2021). Through undersigned counsel, Mr. Mullins respectfully moves this Honorable Court to withdraw the location restriction and monitoring conditions - provisions 7(p) and 7(q) - from said Order.

Pretrial Services Officer Joshua Rose, who is providing courtesy supervision in the Western District of Kentucky - Paducah Division, confirms that this requested modification is appropriate and does not oppose this motion.

Government counsel in Washington, D.C. opposes this motion.

Dear Judge Sullivan:

I am Nancy Mullins the wife of Clayton Mullins. I am 50 years of age and have worked as a physical therapist in the local hospital of Mayfield, KY for the past 20 years. Clayton and I were married 4/14/2000 but we have been together since I was in 7th grade. So therefore I know him quite well to say the least. I can tell you from the bottom of my heart my husband would never hurt anyone. He loves the Lord, his wife, his family, his friends and his country. He respects law enforcement and veterans. He like most of his family and friends want this country to prosper and stay true to the constitution and Christian values.

I am asking you to consider my examples of my dear husband when you preside over his case. He grew up in Wingo, KY a small town in Graves County. He is an outgoing man that loves to work hard to achieve the American dream of success. He grew up in a loving and Christian home with not much money but that didn't matter to his parents and five siblings. As a child he worked hard at home cutting wood for their wood burning stove, helping at the stockyards feeding, loading & sorting cattle and helping tend tobacco for local farmers. He started at seventeen buying inexpensive vehicles and fixing them up to resale. By the time he was out of high school he worked for the Graves County Property Valuation Administration office and continued trading vehicles. In his late 20's he borrowed money to start a successful pallet building business. He then in early 30's began a business buying & selling heavy equipment. He also traveled thousands of miles to heavy equipment auctions all over this country to buy for a dealer in Tennessee. He did this for many years while running his own business. He now continues to work hard in his 50's at the Mullins Machinery, LLC business in Hickory, KY.

During these many years of travel and meeting people he got to know hundreds of business owners, auctioneers and buyers. Many have contacted us and want to know if they can help him in any way. They have also written letters to you confirming his honesty and trustworthiness. These men have grown to love Clayton for his advice on business and personal matters.


Clayton's dad died when he was in high school and Clayton took on the responsibility of caring for his mother until her death in her 80's. His mother instilled in him Christian values. Due to that raising he has helped so many people that were down and out. I know of at least three homeless men he has helped. Two have lived in his mother's old home place. He also allowed our pastor at Little Obion Baptist Church to use this home as a place of residence for several years free of charge. Another instance Clayton bought

a camper to allow a homeless man to stay on his property free of charge. He also helped a man just out of jail by providing him with a place to live and a job until he got back on his feet. He has taught young men how to trade and begin businesses of their own. He is the leader of our church due to our church seeking a pastor at this time. He opens the church every Sunday, organizes fill-in preachers to preach every Sunday, leads the singing and announcements, he is treasurer and he performs maintenance duties. Clayton has many pastor friends and they have all been deeply distressed by this circumstance. They have been a huge support to Clayton and I by their many prayers and words of encouragement and kindness.

My husband is respected in this community by many and we have been overwhelmed by support and love during this time. People have said things like "Clayton Mullins would not hurt anyone." "I know good and well Clayton would not hurt a cop." and etc. People have brought food and strangers have come to our home to pray with us and offer help. We are still getting cards in the mail and emails saying they are praying. It is very humbling to know we have so many people that support us and know my husband's heart.

Again my husband is a man that respects and honors police and knows better to cause them harm. He has many law enforcement and first responder friends and family - state police, city police, firemen, EMS & ex-FBI. He went to the Washington, DC out of love for his country along with many of Americans. We did not know it would end up in such tragedy and a day that has scarred our hearts. I know my husband and he is deeply sorry for the ones that lost their lives and those that were injured on that day. He has cried many tears of sorrow as well as I. We pray for those families that are still healing from loss of life and from injury.

Dear Judge Sullivan:

I am a 53-year-old mother of two children, and I have three grandchildren. I am an office manager of a fire protection company in Paducah, Kentucky. I am also the secretary of my church. Clayton is my brother.

I am asking that even though I am Clayton's sister, if you will consider the information about Clayton that I am writing to you about. I want you to know the type of person that my brother truly is.

Clayton and I are 13 months apart in age. We grew up together on a small farm in a two-bedroom house with our father and mother that was married for 49 years before our father's passing. Our father was a farmer, hauled livestock, a WWII veteran, that loved God, his family and country. Our mother was a homemaker that also loved God, her family and country. They both worked hard all their lives to provide for their family. We attended church services faithfully Sundays and Wednesday nights. They taught us by word and example how to honor God, honor them, to respect our elders and people of authority. They taught us that if we saw someone in need and had opportunity to help them, to do so.

Clayton and I were late in life babies coming 25 years after our oldest sister, 20 years after our oldest brother and 12 years after our other sister. Our parents were in their early 40's when we were born. Clayton and I were close growing up and are still close today. I had fun growing up with Clayton. He was always making me laugh, always thinking of fun things for us to do, a good brother. Clayton has always had a tender, compassionate heart and was thankful for how our parents sacrificed to give us what we needed. We were not rich, maybe poor in some people's eyes, but we were rich with the love of our parents and family.

Clayton never liked to see anyone get mistreated or hurt in any way even when he was a young age. He really didn't like anyone downgrading anything that our parents did for us or gave us. He defended them to anyone that was being derogatory about them in any way. In elementary school, he attempted to help those that couldn't defend themselves. He tried to be a friend to everyone.

Clayton didn't change even in his teenage years. He worked at several jobs to buy his own vehicles and all expenses that entails. He had many friends in high school and at the places he worked. I must admit, he wasn't the best student in high school and had to take extra credit work home in order to graduate. I tried to help him with this because our mother was adamant that he was getting a high school diploma! It wasn't easy to get him to sit down and do the work because he is a person that doesn't like to sit still. He was always busy. But he finished the extra work and graduated.

I watched Clayton change from an immature teenager to a mature man. I watched how his faith in God grew and how he tried to serve Him each day. He doesn't drink, smoke or swear, he lives a clean life and I know that he truly put his faith and trust in God's finished work by the example that he lives. He puts God first, loves his wife, his church and his family. He leads the singing at church and is the treasurer. The church doesn't have a pastor currently, so he opens and closes the buildings before and after services and is trying to find a pastor.

Clayton is not only my brother, but he is my best friend. I can always count on him whenever I am in need. Clayton and his wife, Nancy have always been there for me. He has helped me at many different times in my life. Both helped me when I went through a heart-wrenching divorce. I was a homemaker with no job, no income and nowhere to live. Also, at that time our elderly mother was sick, and we were dealing with all that entails. It was a dark time for me, Clayton helped me to not get discouraged but encouraged me continuously until I found a job to support myself and my two children. They also let me, and my two children move into their home until I found a place to live. Our mother was there also, and it was a full house. They helped me look for a house and they let us stay with them until I bought a house. He loaned me the down payment money for my house, and I paid him back as soon as I received the life insurance money that I cashed in. I know it had to be hard for them with all those people in their home, but I truly appreciate all they sacrificed for us at that time. I don't know what I would have done without them and their help. Since then, I haven't remarried and whenever something goes wrong with my vehicle, my home, whatever problem arises, Clayton always helps me take care of it with grace, no grumblings. I fiercely love him and his gentle soul. He and Nancy are the best friends I have ever had in my entire life.

Clayton was so good to our mother. He took better care of her in her last years than I, my two sisters or brother did. I am so ashamed of myself, and I wish that I had done more. She deserved so much more than I gave her. Our mother was a homemaker, so she didn't draw very much money during her retirement years. I have seen Clayton put money in her account repeatedly for several years when her account was getting low. I didn't do that, nor did my sisters and other

brother do it either. He would take her with him when he ran errands for his business or drive her around to any place that she wanted to go. Nancy and he would also take her with them on their vacations. She never went anywhere her whole life. She was so thankful to be able to go. Clayton spent a lot of time with her. I am so grateful that he did that for our mother. He showed me how a person should treat people that they love no matter what is going on in our lives.

I have also watched Clayton help many people through past years that were going through rough times. He has helped people get back on their feet when they have lost everything by giving them a job or help them with a place to live when they have nowhere else to go. I have watched him help several people start their own business by giving them advice and providing equipment to use until they can pay him back. People that know Clayton respect him because he is honest, and they know that can truly rely on him. He is a kind and compassionate man that anyone can go to when they are in need.

I am blessed that he is my brother and that he is also my friend. I couldn't have asked for a better person for God to place in my life.

I am Ricky Dale Mullins, the only brother of Clayton Ray Mullins. I reside in Mayfield, Kentucky, and am an Army Veteran serving during the Vietnam era. I worked at Ingersoll Rand for 30 years as a cooler machine operator, until company relocation in 2001. But I officially retired in 2010. I am a member of Trace Creek Baptist Church. I am writing to you today to express my support for my brother Clayton Ray Mullins. Hopefully, my experiences with him will help the court better understand who he is as a person.

Given that Clayton is the youngest of my siblings, I have had the honor of knowing him his entire life. He was born while I was serving my country in the late 1960s. I have fond memories of him in his youth, such as attending church with him at Little Obion Baptist Church. However, we are much closer today. Our relationship goes far beyond the ties we have as a family. After Ingersoll Rand closed their Mayfield, Kentucky plant, I was left unemployed from my job of 30 years. We are ashamed at the media but everyone that knows Clayton says they are praying for him and Nancy. We have a very close community they are loved by many people! They have God in their hearts and he will see them thru this awful mess! I pray that they can get back to their normal lives again. Dear Judge Sullivan:

I have been an orthopedic surgeon for the last 38 years and practice here in my native western Kentucky. I have also served as an orthopedic surgeon and flight surgeon in the Kentucky Air National Guard and in the US Air Force Reserve including service in the Middle East during Operation Desert Storm.

I have known Clayton Mullins for around 25 years. I initially got to know Clayton as a reliable and hard worker in the early 1990's when he was helping my Dad round up cattle that didn't want to be rounded up on the family farm. I also have known him through his friendship with my brother Ben. Ben had to occasionally buy used equipment for our father's construction company. Clayton had earlier learned the cattle auction business and also had, by nature, good skills in relating to and dealing with other people. Clayton freely passed on some of these skills to my brother in learning how to value and purchase used construction equipment. My brother has built a successful equipment business that provides an affordable equipment rental option to the community and jobs for his employees. His success is due, in part, to Clayton's willingness to give freely of himself to others.

I have also gotten to know Clayton through my practice as an orthopedic surgeon. Clayton's high school sweetheart and wife, Nancy, is a physical therapist at the hospital where I operated for years. She has routinely cared for my patients, as well as members of my family. Seeing her every week at the hospital has allowed me to keep up with Clayton's activities over the years as he has built his own successful business in used equipment sales. Ever industrious, at one time a few years ago, Clayton had a business recycling used pallets. One of his employees sustained a severe hand injury which I cared for. Clayton's concern for his employee was demonstrated by his showing up in person at the hospital and at my office to assure that anything that I needed of him as the employer would be readily supplied. In my 38 years of experience, it has been extremely rare to see the boss of an injured worker show up in person but Clayton is one of those rare caring exceptions.

In our chosen professions, we both have to deal with people who have gotten themselves into trouble - you with the legal consequences and me with the medical consequences. You have to make the tougher decisions. I've had patients shot in the course of committing a robbery, drunk drivers who killed others and injured themselves, and gang members who have blown themselves up while arming a bomb meant for others. No one has sympathy for such patients. There are patients injured through no fault of their own - hit by a car that swerved into their lane or crushed by an equipment failure in a factory. They have our total sympathy. Then there are those patients in the middle. They start out with the best of intentions but make a bad last-minute decision that gets them hurt - such as diving into too shallow water while egged on by a crowd. I believe Clayton falls into this last category.

The medical decisions and treatment are the same for all of these classes of patients but not so the legal decisions a judge must make. Unlike a judge, I do not have to weigh mitigating circumstances. Through his good nature, ethic for hard work, and self-taught business acumen, Clayton has done quite well for a country boy. I have always known Clayton to be soft-spoken, a good listener, and kind. I have never heard him speak in bellicose terms or express extreme views on politics or other subjects. He neither smokes, nor drinks, nor uses profanity. He is devoted to his church and he is a devoted husband. I am certain that he would never have taken Nancy with him to Washington if he had even remotely contemplated involvement in anything illegal, much less any physical altercation.

I do not envy your position. Everyone wants fairness and justice. For half of the country, justice will only be served by seeing Clayton hung from the highest yardarm and you are the only person between Clayton and that outcome. It is my understanding that you allowed Clayton out on bail despite the Justice Department asking that he remain incarcerated. I found that decision courageous and heartening. Anyone who knows Clayton and Nancy Mullins knows that Clayton is no risk for flight or further mischief. Crime and politics is an absolutely toxic mixture that can make for a state pursuing overly harsh punishments, not just to punish the crime itself, but also to set an example to political opponents, e.g. the 1916 Easter Rising in Ireland. Clayton is the kind of guy who will face up to his mistakes and take his fair number of licks. I trust that you are the kind of judge who will resist the political pressures, weigh Clayton's charges and mitigating circumstances, and arrive at a fair number of licks. Thank you for your consideration.

My name is Ben Crawford. I am the owner of a local equipment rental company and I do my best to be a respectable business owner. I believe that I am well liked and respected by most that know me.

I have known Clayton Mullins since 1992. Within a year of meeting Clayton I found myself working as a contractor on a construction job that was way behind. Clayton volunteered to help and worked with me for over two weeks until the job was completed. Although Clayton was paid, he never asked about payment or a wage rate. I am sure that he would have done it for free had I asked him. He did not do this because he was indebted to me but because he simply enjoys working and helping others.

Since that time Clayton and I have been close friends. Throughout those years he has always been involved with his church, usually going three times a week. He would invite most everyone that he developed a relationship with and many did and do go to church with him. He does not drink or use tobacco and I cannot remember ever hearing him utter a curse word.

During each of our courses of business Clayton and I would attend many auctions together. These auctions can bring a wide variety of people, and as you can imagine, some auction goers do not know how to act in a way that would be considered proper. I remember a time when a group of people at an auction were rather loudly cussing and using the Lord's name in vain. When Clayton overheard it, he walked over and asked if he could join them. When they gave him a confused look, he explained that he had overheard them talking about God, and assumed they were having Bible study and wanted to know if he could join them. That time was one of many that he has gently let people know that they may want to reflect on the way they were acting. While we all encounter people who we do not agree with, I have never known Clayton to raise a hand to anyone. He is compassionate and has always stood up for the little guy that he felt was being bullied.

After my wife and I were married I would occasionally ask Clayton to meet me at my house. As is my nature, I would be running late more often than not. When my wife would invite him to wait for me inside, he would say that he would just walk around our subdivision and get some exercise. After a couple of years of this I finally realized that although he enjoyed the exercise he didn't think it looked right for he and my wife to be together without me there. The thought never crossed my mind but it did his, and he wanted to be sure to do the right thing.

As Clayton's mother aged he would take her with him most everywhere he went. Since he is self-employed, he had the ability to take Jo (his mother) with him to his shop and while

traveling and buying or selling equipment. He enjoyed spending his day with her, and it kept her busy and engaged so she lead a more active life which I am sure helped her to live a longer and happier life. Having Jo with him did slow things down but he never once complained. He knew that spending time with those that you love was more important than making more money. I used to say that when I was driving I would have my dog with me, but when you would see Clayton he would have Jo.

Although I would have loved to have met him I never knew Clayton's dad. He passed away when Clayton was a teenager and before we met. Clayton is the youngest of his siblings and that was very stressful on Clayton and his family. Even with his early demise, he and Jo gave their children love, taught them a good work ethic, and raised all good, hard working, responsible, productive, and God-fearing adults, and I know that our society is better having each of them in it.

Clayton has true concern for everyone in my family. My dad was a former WW2 pilot and long-time businessman. At the age of 95 my dad was diagnosed with pancreatic cancer and passed away from it over a year later at the age of 96. The day that my dad passed away Clayton was there with us which was quite comforting. He would hold dad's hand and try to get him to drink something. It was a very humbling experience to have our friend there spoon feeding dad and begging him to just drink a sip of water, all the time still calling him "Mr. Crawford." It was then that I took my last picture of dad there with Clayton by his side. I chose to take the picture not because I wanted to remember seeing dad that way but because I did not want to forget the love that was being given to my dad and our family in our time of sorrow.

Dad passed away within an hour. I am including a picture from that day because I want to try * and convey to you the good, loving, and harmless person that Clayton has been ever since I have known him. When I think of Clayton and the characteristics that define him, I have over 30 years of memories to choose from. It troubles me to know that many who do not know him are attempting to judge his character by examining only a thin sliver of his life. I wish they could review his actions of love that could be seen on the other 18,000 days of his life, but I guess that is something that only the Lord can do.

I thank you for taking on the difficult task of having to assess the character of the people that come before you. I am sure this is a task that you take very seriously knowing how greatly your decision will affect all of those involved. It must be difficult on you and your staff and I would like you to know that I have been and will be lifting up you and your staff in prayer. I have known Clayton for over 30 years and, contrary to the belief of some, I can assure you that our society is a better place having Clayton in it. I humbly ask that you show leniency and mercy toward my friend.

My name is Thomas Fortner. I am an 86 year old retired Baptist minister. I live in Trenton, Tennessee.


It is the purpose of my communication to provide the Court with information related to my personal relationship with Clayton.







I am trying so hard to find the correct words that can express just how passionate I am for the opportunity to write this letter.


