**JOINT NOTICE REGARDING FACEBOOK EXHIBITS**

The United States of America, by and through its attorney, the United States Attorney for the District of Columbia, and the defendant, Russell Dean Alford, by and through his attorneys, jointly file the following notice regarding the exhibits from the defendant’s Facebook account that the government will seek to introduce at trial.

At a hearing on September 23, 2022, and later in an order dated September 24, 2022, the Court ordered the government to identify no more than seven exhibits from a selection of thirteen exhibits drawn from the defendant’s Facebook account (302, 303, 304, 305, 306, 307, 308, 309, 315, 316, 317, 318, 323). The government intends to offer the following seven: 302, 303, 305, 306, 317, 318, and 323. The government has provided defense counsel with copies of these exhibits, and attaches the collected seven as an exhibit to this joint notice.

Although Mr. Alford respects the Court’s decision to overrule his pretrial objections in part as to seven pre-January 6 Facebook exhibits, he respectfully maintains his earlier specific objections (as set forth in ECF Nos. 67 and 78) and reserves his right to raise any in-trial objections to any or all of these, as appropriate.
