DEFENDANT'S UNOPPOSED MOTION TO CONTINUE SENTENCING HEARING AND

TO EXTEND TIME WITHIN WHICH TO FILE SENTENCING MEMORANDUM

The Defendant, **JOSHUA MATTHEW BLACK**, by and through his attorney, Clark U. Fleckinger II, moves this Honorable Court, without opposition, to continue the sentencing hearing in the above captioned matter, currently scheduled for May 2023, to May 16, 2023, and to extend the time within which to file his Sentencing Memorandum to May 8, 2023. 3. That, accordingly, undersigned counsel requests that sentencing in the above referenced matter be postponed to May 16, 2023¹ and that the time within which to file a

sentencing memorandum on behalf of Mr. Black be extended to May 8, 2023.

4. That, the Government has no opposition to the either of the requests made

herein.

5. That, AUSA Eric Boylan, one of the AUSAs who tried the above captioned

matter with AUSA Seth Adam Meinero and AUSA Emily Allen is in the process of moving

his family from Texas to the District of Columbia and will be unable to appear for the May

16 sentencing in person. Accordingly, is requesting that he be permitted to appear remotely.

Mr. Black has no opposition to Mr. Boylan appearing remotely for the May 16 sentencing

proceeding.

WHEREFORE, the Defendant respectfully requests that the Court continue the

currently scheduled May 5, 2023 sentencing in the above captioned matter to May 16, 2023

and that the time within which to file a sentencing memorandum on behalf of Mr. Black be

extended to May 8, 2023.
