MINUTE ORDER as to BOYD CAMPER. The Court held a status hearing in this matter on May 19, 2021. Due to the health concerns surrounding COVID-19 and with Defendant's consent, the status hearing was held by videoconference. Defendant, counsel for both parties, and a court reporter were present. Defendant was presented on the charges in the 17 Information. Defendant confirmed that he had received a copy of the Information. Defendant was read the four counts contained in the Information and entered a plea of "not guilty" as to all counts. During the status hearing, the Court discussed discovery and advised the government of its continuing Brady obligations in this case. See ECF No. 19. The parties indicated that discovery is ongoing. To allow the parties additional time to proceed with discovery and to discuss resolution of the case, at the request of the parties, the Court has scheduled another status hearing for JULY 30, 2021 at 9:30am. Defendant consented to this status hearing proceeding remotely via videoconference. During the May 19, 2021 status hearing, the Court discussed with Defendant his Speedy Trial Act rights. At the time of the May 19, 2021 status hearing, the Court calculated that Defendant's 70-day deadline under the Speedy Trial Act was JULY 19, 2021. See 18 U.S.C. § 3161. As stated during the May 19, 2021 status hearing, the Court finds that a continuance of Defendant's Speedy Trial rights between May 10, 2021 and the date of the next status hearing on July 30, 2021 serves the "ends of justice" as it will allow Defendant to obtain and review discovery with his counsel, and to discuss potential pre-trial disposition of this case. Defendant had previously

consented to toll his Speedy Trial rights through May 10, 2021 (See 3/15/21 Minute Entry). At the May 19, 2021 status hearing, Defendant consented to the tolling of his Speedy Trial rights between May 10, 2021 and the next Status Hearing on July 30, 2021. Taking into account this continuance, the Court has calculated that Defendant's new 70-day deadline is OCTOBER 7, 2021. Signed by Judge Colleen Kollar-Kotelly on 5/19/2021.
