Based on the defendants' request for a continuance, and the government's lack of opposition thereto, the status hearing previously scheduled for June 3, 2021 is VACATED. A status hearing is set for June 25, 2021 at 1:00 PM. In addition, the Court finds that the "ends of justice outweigh the best interest of the public and the defendant in a speedy trial." 18 U.S.C. § 3161(h)(7)(A). Specifically, failure to grant a continuance in this case would deny counsel for the defendant "the reasonable time necessary for effective preparation" based on the early stage of this case and the need to review forthcoming discovery. 18 U.S.C. § 3161(h)(7)(B)(iv). Accordingly, pursuant to the Speedy Trial Act and with the consent of the defendant, the time from June 2, 2021 through June 25, 2021 shall be excluded in computing the date for a speedy trial in this case. Finally, the Court was just informed by Pretrial Services that neither defendant has made contact with the courtesy supervision jurisdiction. The defendants are ORDERED to contact Pretrial Services immediately. Pretrial Services shall notify the Court if the defendants have not complied with the Court's order on or before the
