MINUTE ORDER as to FELICIA KONOLD (3): Defendant requests that the Court vacate sections 7(p)(ii) and 7(q) of her 37 Order Setting Conditions of Release which impose home detention and location monitoring conditions. In support of her motion, Defendant submits that "the conditions at issue are simply unnecessary as she has earned the trust of the Court by obeying orders and showing up for court proceedings to date without incident." ECF No. 56 ¶ 8. Defendant's "compliance-even model compliance-with the Court's requirements is not enough to warrant adjustment of her pretrial release conditions." United States v. Henry, 314 F. Supp. 3d 130, 133 (D.D.C. 2018). Defendant has provided no new information or new development of her situation that "would affect the Court's assessment of the 'least restrictive' conditions of release that 'will reasonably assure the safety of any other person and the community.'" Id. (quoting 18 U.S.C. § 3142(c)). Defendant argues that the conditions restrict her ability to work and place a burden on her ability to care for her family by limiting her movements. As the Government points out, her conditions already allow her to arrange with the Pretrial Services Agency times to travel to work and to run errands, so long as those arrangements are made in advance. ECF No. 37 at § 7(p). Accordingly, it is hereby ORDERED that Defendant's 56 Amended Motion for Bond Review is DENIED. It is further ORDERED that Defendant's 55 Motion for Bond Review is also DENIED.
