At the time of the May 24, 2021 status hearing, the Court calculated that Defendant's 70-day deadline under the Speedy Trial Act was August 2, 2021. See 18 U.S.C. § 3161. As stated during the status hearing, the Court finds that a continuance of Defendant's Speedy Trial rights between May 23, 2021 and the date of the next status hearing on July 14, 2021 serves the "ends of justice" as it will allow Defendant to obtain and review discovery with his counsel. At the May 24, 2021 status hearing, Defendant consented to the tolling of his Speedy Trial rights between May 24, 2021 and the next Status Hearing on July 14, 2021.
