It is not standard practice in this Court during sentencing hearings that follow trials for the parties to re-introduce and re-publish exhibits that are already in the record. The Court is very familiar with the evidence, and now that the defendant's post-trial motions have been denied, the purpose of allocution is not to impugn or re-litigate the jury's verdict, but to determine what the appropriate sentence should be. The Court expects both parties to be focused, and to make judicious use of the exhibits that have already been introduced, as they make their arguments on how the statutory sentencing factors should apply, showing only exhibits that are absolutely necessary, if any. Since the jury hung on the count involving aiding and abetting the theft of the laptop, and the government has dismissed it, see [125], there is no reason why the hearing should include revisiting the Rondons or any evidence with respect to that count at all. Furthermore, it will not be necessary to play the video of the former President's speech in order to discuss its contents, if they have any relevance given the hung jury and dismissal of Count Two. The defense will remain free, of course, to refer to or characterize any evidence that bears on the counts of conviction when discussing any of the factors set forth in section 3553. SO ORDERED.
