Upon consideration of Pretrial Services' 17 18 Compliance Reports, it is ORDERED that the defendants' conditions of release are modified such that the defendants shall report as soon as possible to pretrial services or the supervising officer every contact with law enforcement personnel, including arrests, questioning, or traffic stops.
