Due to the health concerns surrounding COVID-19 and with Defendant's consent, the status hearing was held by videoconference. Defendant, counsel for both parties, and a court reporter were present. Defendant was presented on the charges in the 9 Information. Defendant confirmed that he had received a copy of the Information and waived formal reading of the Information. Defendant was read the substance of the four counts contained in the Information and entered a plea of "not guilty" as to all four counts. During the status hearing, the Court discussed discovery and advised the government of its continuing Brady obligations in this case. See ECF No. 13. The government indicated that it had not yet been able to provide discovery to Defendant due to ongoing negotiations regarding a protective order. The most recent COVID-19 Standing Order issued by the Chief Judge of the District Court excludes the time period through March 15, 2021 under the Speedy Trial Act. See In re: Sixth Extension of Postponed Jury Trials Due to Ongoing Exigent Circumstances Caused by COVID-19 Pandemic, Standing Order No. 20-93. Accordingly, Defendant's correct 70-day deadline under the Speedy Trial Act at the time of the March 2, 2021 status hearing was MAY 24, 2021 for his 70-day deadline. See 18 U.S.C. § 3161.
