¹ The law and arguments presented in Mr. Judd's motion apply equally to Mr. Stevens, even though they are charged in different counts. Mr. Stevens is charged in Count 36 with disorderly and disruptive conduct in a restricted building or grounds with a deadly weapon, in violation of 18 U.S.C. §§ 1752(a)(2) and (b)(1)(A), and in Count 44 and with engaging in physical violence in a restricted building or grounds with a deadly or dangerous weapon, in violation of 18 U.S.C. §§ 1752(a)(4) and (b)(1)(A). ECF No. 179.
