DEFENDANT'S UNOPPOSED MOTION TO ALLOW THE DEFENDANT ATTEND CHURCH SERVICES ON CHRISTMAS DAY AND VISIT WITH RELATIVES

Defendant Matthew Greene, by and through undersigned counsel, submits the following unopposed motion seeking the Court's permission for the Defendant to attend church services and visit family on Christmas Day (12\25\22).

On December 22, 2021, the Defendant entered a guilty plea, pursuant to a cooperation agreement with the government and the Court. On March 10, 2022, the Court granted the unopposed motion of counsel to release the Defendant to home incarceration in the Northern District of New York, while he is awaiting sentencing. The terms of home incarceration included electronic location monitoring.

Department in the Northern District of New York and confirmed that Mr. Greene has been in

compliance with the terms set forth by the Court. Additionally, counsel has conferred with

Assistant United States Attorney Erik Kenerson and the government does not oppose the relief

sought in this motion.

WHEREFORE, the Defendant respectfully requests that he be permitted to attend church

services and visit family on Christmas Day $(12\25\22)$.
