**DEFENDANT’S MOTION TO APPEAR VIA VIDEO
TELECONFERENCING ON JULY 11, 2022 AT 10:00 AM**

COMES NOW, Defendant, William McCall Calhoun, Jr., by his undersigned counsel, Jessica N. Sherman-Stoltz, Esq., and respectfully requests that this Honorable Court allow him and his attorney to appear by way of video teleconferencing (Zoom) for his upcoming July 11, 2022 Motions Hearing. In support, he states as follows:

1. Defendant lives and works in the state of Georgia. Undersigned counsel lives and works in Virginia (Gum Spring and Waynesboro).
2. Defendant recently had surgery on his right foot, and by his doctor’s order, is unable to travel until after January 1, 2023. *See* Exhibit A.
3. Defendant has appeared via video teleconferencing at every proceeding related to his case since his initial appearance on January 15, 2021.
4. On May 12, 2022, pursuant to the CARES Act, authorization for the use of video teleconferencing was continued for ninety (90) days, until August 11, 2022, for criminal proceedings enumerated in § 15002(b)(1) of the CARES Act.

5. Out of respect for Defendant's retainer, and to reduce the billable hours for what has been a lengthy criminal case, undersigned counsel also requests to appear via video teleconferencing on July 11, 2022.
6. The attorney for the Government, Assistant United States Attorney, Deputy Chief, Brief and Assault Unit, Capital Siege Investigations, Jennifer Rozzoni, has advised she does not oppose this motion and request, and that she can appear via zoom or in-person as she will be in the District of Columbia on Monday, July 11, 2022.

WHEREFORE, for the foregoing reasons, Defendant respectfully requests that this Honorable Court allow him and undersigned counsel to appear via video teleconferencing for his July 11, 2022 motions hearing.
