I am writing this letter on behalf of my mother-in-law, Dawn Bancroft for your consideration when determining sentencing for her part in the insurrection that took place on January 6, 2021. My name is Patrick Armstrong, and I am married to her daughter, Krystin; I have known Dawn for over five years and I truly believe she is a good person who made a severe mistake, that I must say I couldn't disagree with more.

I brought a child from a previous relationship into my relationship with Krystin and Dawn had accepted her without question and has always treated her with love and respect. Even when Krystin and I had our own baby, nothing changed with her view of Ella being her granddaughter and that has meant the world to me. I know this might sound like a simple thing, but I think that it shows the true loving nature of her.

As far as the comments she made while in/around the Capitol, I must admit that I was very troubled when I heard what she had said, and I do not condone her actions or words in any form. To be honest, I know that Dawn is completely against physical violence of any kind and I truly believe that she was caught up in the moment with the other insurrectionists and just said something extremely stupid, but never had or would ever have any intention of harming anyone. I do know how bad her words were, but I don't believe that to be the true Dawn. And if I did believe she could/would be violent, I certainly would not want or allow my children to spend time with her; not only for their safety, but also for their mental and emotional wellbeing. My children are by far the most important people in my life, and I feel good about them being around their grandmother and I believe they only receive positive things from her.

I understand that adults are held to a certain standard and need to face the consequences of their actions, but I know that Dawn knows what she did was extremely wrong and that she regrets her part in that horrific afternoon. She owned up to her actions when the investigators approached her and was as helpful as she could be with immediately providing everything they asked for – photos, videos, names of people, etc. She has faced public and private humiliation and I am sure she will have to pay a hefty fine, but I do request that you show mercy to her and do not sentence her to any jail time. I believe that in this case, a sentence that includes community service/outreach would be much more productive for her and the community than to put her in jail.

This country has been greatly divided and those divisions were exploited and exasperated by a man who held the highest seat in our government; who nearly half of us Americans voted for to stay in office which I must say is unbelievable to me. I believe that Dawn thought she was being led by Trump and did what he asked her to do, along with many other Americans. I know this doesn't excuse her behavior, but it certainly is a fact that must be considered as many of us Americans somehow agree with and sympathize with him (not me!).

In summary, I know that Dawn is a loving person who would never condone violence and as simple and stupid as it seems, she got caught up in the frenzy of Trump's time in office. Dawn Bancroft is a loving mother and grandmother, and has dedicated her life to helping people; through coaching, training and overall wellness support in her 30+ years of fitness instruction. She is a source of consistent encouragement, a shoulder to lean on, and her clients' biggest advocate. Over the past 15 years, as a single woman, she has been a local business owner and positive influence in our small town, hosting fundraising events, holiday open houses, and of course fitness and nutrition challenges for beginners through professionals. Dear Judge Sullivan,

My name is Kenann Kelly. I am a 54 year old married mother of two children. I have lived and worked in the Doylestown, PA area for 24 years. I have a successful career in Technology Sales as a Field Account Manager. My hobbies include reading, travel, cooking and CrossFit. I met Dawn Bancroft when I started CrossFit. We have known each other for almost 10 years. I am writing this letter in the hopes that you will have a better understanding as to who she is as a person.

Dawn and I met in February 2012, when I first began my fitness journey with CrossFit. Dawn owned and coached at CrossFit Sinepari in Plumstead, PA. It was the first CrossFit affiliate I tried and I never looked back. Dawn was and still is a great fitness coach. She knows how to encourage people to try harder in order to achieve their goals, both mentally and physically. I have personally witnessed members lose as much as 80lbs and become more confident in themselves with what they could do. I myself lost at least 20lbs.

When I first started CrossFit, I was sadly out of shape. I remember my first workout with existing members who were at least 10 years older than me. They were out running me, lifting heavier weights and basically kicking my butt. I could not do a pull-up, push-up, handstand, power cleans, snatches or Double Unders. Now at 54, I can. It might not seem like a big deal, but it is to me. It has not only transformed my physique, but my mental health as well. I have stamina, confidence and a "can't wait to tackle my day" feeling after a CrossFit workout. All of these achievements I owe to Dawn.

Dawn cares about her members, her family and her community. When I first started CrossFit I remember certain days we would do a Hero WOD (Workout of the Day). The hero was named after a soldier or first responder who gave the ultimate sacrifice. Dawn would read the story of each hero to the class and would always tear-up and struggle to finish. It was very touching. She would then end it with "No complaining about this WOD. You're alive. They are not!!"

Dawn is patriotic. She loves her country and those that fight for it and protect it. This past summer, she asked for contributions for a high-school gym member who graduated in June and joined the army. Joel Campos had joined the gym so that he could get ready for boot camp. He really liked the Apple Watch that other gym members had to track their fitness. He did not have money to buy one so she started a collection to buy him one as a send-off gift. It was very sweet as he was really touched by the generosity of the gym. However, I strongly suspect she paid for most of it as her gym members are significantly lower since January 6th.

Dawn is very social as well as a motivator. Every year (pre-Covid), she would host fun competitions; such as the CrossFit games at the gym. Members would compete against each

other on teams in a fun and spirited environment. This was always followed by a social event at her house. She would also organize groups to participate in other CrossFit competitions, Tough Mudder's or other running events that were outside of CrossFit. She would have nutrition challenges at the gym with prizes to motivate everyone to eat healthy.

Dawn has a generous and compassionate heart. She organized fundraisers and social events for members who have lost loved ones to cancer, addiction etc. She had t-shirts made up for one fund raiser event with the quote: "Tough times don't last, but tough people do!" It was a really fun event but had a special meaning to everyone. This type of camaraderie and genuineness always resonated with her members and even when they left due to life events they would come back. A perfect example is her famous 12 days of Christmas WOD where former members who moved away would come by on Christmas Eve to do this special workout. It was always packed with members past, present and future. That speaks a lot about the positive effect she has had on her clients.

Besides her leadership in fitness and health in her community, she has been a great friend. We have had countless conversations of her remorse over the January 6th event. She has stated that she wished she could undo what she did. She talks about it all the time. It hurt her reputation (she lost her CrossFit affiliation), she lost close friends, gym members, and more importantly it has taken a toll on her children. I have witnessed the close bond she has with her kids. I have attended her oldest daughter's wedding this past May. They love their Mom very much and she loves them. She is truly a good person who did a really stupid thing which she freely admits all the time.

For the reasons above your honor, I ask that you show Dawn mercy. She realizes what she has done was wrong. The emotional toll it has taken on her with the loss of friendship and disrespect in the community has been the worst punishment she could receive. It is something she now has to live with the rest of her life and it weighs on her tremendously. Please take this into consideration as you determine her sentence.
