Mr. Shawn Witzemann Documented Journalist History

Mr. Shawn Witzemann started his journalism career in 2016 when exposing corruption and negligence in regards to a San Juan County, New Mexico utility provider in 2016. Mr. Witzemann expanded beyond that singular story in June 2018 when he created a Facebook page called "Farmington Tribune". Mr. Witzemann, along with others on his growing team on Farmington Tribune employed satire as a way to bring attention to underreported issues in his immediate community and the world at large. Another focus of Farmington Tribune was to expose underrated stories ignored or under-reported by mainstream media

Farmington Tribune grew to a regular reach of 14,000 followers, and in late 2019, Mr. Witzemann officially formed the media company, Tribune Media International L.L.C., Tribune Media International L.L.C., was started in order to manage multiple publications and information distribution platforms, production of four distinct live broadcasts, various documentary projects, and a network of field reporters and other contributors from around the globe.

Through the numerous social media assets of Tribune Media International L.L.C, including the nightly newscast "The Armenian Council for Truth in Journalism", Mr. Witzemann established niche media expertise in covering protests stemming from the murder of George Floyd. Mr. Witzemann either facilitated, or personally provided live-stream media coverage of protests and riots across the United States.
