AMENDED JOINT PRETRIAL STATEMENT

I. Joint Statement of the Case

The United States has charged Luke Russell Coffee with offenses that occurred at the United States Capitol on January 6, 2021. Count One charges Mr. Coffee with civil disorder. Count Two charges Mr. Coffee with forcibly assaulting, resisting, opposing, impeding, intimidating, and interfering with law enforcement officers from the United States Capitol Police while using a deadly or dangerous weapon. Count Three charges Mr. Coffee with forcibly assaulting, resisting, opposing, impeding, intimidating, and interfering with law enforcement officers from the United States Capitol Police while using a deadly or dangerous weapon. Count Four charges Mr. Coffee with entering and remaining in a restricted building or grounds with a deadly or dangerous weapon. Count Five charges Mr. Coffee with disorderly and disruptive conduct in a restricted building or grounds with a deadly or dangerous weapon. Count Six charges Mr. Coffee with impeding ingress and egress in a restricted building or grounds with a deadly or dangerous weapon. Count Seven charges Mr. Coffee with engaging in physical violence in a restricted building or grounds with a deadly or dangerous weapon. Count Eight charges Mr. Coffee with disorderly conduct in a Capitol building. Count Nine charges Mr. Coffee with impeding passage through the Capitol grounds or buildings. Count Ten charges Mr. Coffee with

engaging in an act of physical violence in the Capitol grounds or buildings.

Mr. Coffee has pleaded not guilty to all charges.

II. Estimated Trial Days

The Parties expect Trial to last 4 to 5 days.¹

III. <u>List of Expert Witnesses</u>

Defense intends to call one or two expert witnesses. Government has not received any disclosures on any defense expert. At the pre-trial hearing, the government may ask the Court to set a deadline for the expert disclosure for the defense and a briefing schedule on the issue of expert testimony.
