### U.S. Capitol Police Department Duties on Capitol Grounds

On January 6, 2021, officers from the United States Capitol Police ("USCP") on the U.S. Capitol grounds and in the U.S. Capitol building were engaged in their official duties as officers or employees of the United States or of any agency in any branch of the United States Government, as those terms are used in Title 18, United States Code, Section 1114.

### **Body Worn Cameras Videos**

The body worn camera videos government exhibits 301, 302 and 303 were created and maintained by the Metropolitan Police Department. The government attests that they are accurate and created using reliable methods and were not altered or edited in any way, and no audio was removed or edited. The government further attests that the videos are authentic in that they are what they purport to be. The recording software timestamps each recording with the date and time at which the footage is captured. The timestamps are accurate. The video and/or any other copies are "admissible into evidence to the same extent as the original," within the meaning of Federal Rule of Evidence 1003.

### Senate Recording Studio

The House Recording Studio and the Senate Recording Studio operate and maintain closed-circuit video monitoring and recording equipment that captures locations inside the House

Chamber and the Senate Chamber. The video equipment timestamps each recording with the date and time at which the footage is captured. This equipment was in good working order on January 6, 2021, and video footage recovered from the cameras and equipment for the day of January 6, 2021 is footage of January 6, 2021. The events depicted in the video footage are a fair and accurate depiction of the events in the Senate Chamber and House Chamber on January 6, 2021. The video footage was not altered or edited in any way and the government attests that no recordings were otherwise spoliated. Timestamps are visible on the recordings, and they are accurate. The video footage is authentic in that it is what it purports to be.

### US Capitol Police Video

The United States Capitol Police ("USCP") operate and maintain closed-circuit video monitoring and recording equipment that captures locations inside and outside of the U.S. Capitol building and on the Capitol grounds. The video equipment timestamps each recording with the date and time at which the footage is captured. The USCP-controlled video equipment was in good working order on January 6, 2021, and video footage recovered from the cameras and equipment for the day of January 6, 2021 is footage of January 6, 2021. The events depicted in the video footage are a fair and accurate depiction of the events at the U.S. Capitol on January 6, 2021. Timestamps are visible on all recordings, and they are accurate.

The video footage was not altered or edited in any way. The video footage is authentic in that it is what it purports to be.
