We are the parents of Samuel Christopher Montoya, our third born child. Pastors of Sinai Pentecostal Church for 52 years and will have been married for 52 years in July of this year, by the Grace of God Almighty. We have been a close knit Christian family and served our community, church and Country with love and devotion. We have stood by our children both in good and bad circumstances—Our oldest son, Jacob, 50, battling Diabetes Mellitus since the tender age of 8, our 44 year old daughter, Priscilla, an ovarian cancer survivor who continues to receive special treatments in her fight to continue to parent her 11 year old son, Luciano and now, Samuel Christopher, who, working for a free speech agency in the City of Austin and having gone to Washington, DC on January 6th, apparently participated in a behavior where he plead guilty to a misdemeanor charge and who is at the mercy of your court for sentencing. We know, beyond a shadow of a doubt, that Samuel regrets this action and has since apologized. We teach our children to learn from their mistakes and to pick up the pieces and better themselves. We truly believe that this can be so in Samuel's case. We appeal to you for leniency for him. Our daughter lives almost 1,000 miles away and our eldest son has been on dialysis for the past five years and is not in good health. Since we are up in years, though still in the pastorate, Samuel has been the son that has looked after us. In 2018, I, Samuel Montoya, went through my own journey with salivary gland cancer, a stage two aggressive cancer, having to undergo 33 radiation treatments. My wife, Melba, has gone through her own health issues and Samuel has been there to run errands, make sure we follow the recovery treatments, etc. He has been our right hand many times. We prayerfully ask you for leniency in the sentencing of our son. Even traveling is now an Issue for us, so if he is sent away from San Marcos, it will sadly put a heavy burden in our hearts. We do what we can for our children, trying to use our resources and strength to show them our love, care and support.

Our son, during all the time of pre-trial and up to this day, (almost two years) has complied with everything the courts have asked of him. He has our love and support 100 percent. We humbly request that you consider us as you make your decision regarding our son's sentencing and know that we will be forever grateful to you, if you exercise leniency toward our son. We will help our son fulfill any and all things requested by the court.

#### Dear Honorable Judge John D. Bates:

I am Samuel C. Montoya's only sister and am writing to request leniency on his sentencing. As a social worker, I sincerely believe that Samuel has experienced the emotional, social and financial consequences of his actions and is truly remorseful. I know Samuel extremely well as his sister. He and I have been very close over the years both in our adolescence and in adulthood. Samuel and I have been roommates as young adults when we both were early in our careers in the state of Georgia.

I believe that the incident that led to the current charge was a complicated and layered result of influence by many people and factors that have come to light over the past several years at the national level. As a professional in the mental health sector, I was honestly concerned regarding Samuel's strong commitment towards a single ideology that was spearheaded by people with lots of financial resources and power. Since the incident, I have noticed that Samuel understands in retrospect that his actions and alignment with his former employer, were grossly misguided.

Over the past two years, Samuel has had time to critically assess his action and its long-term impacts. The emotional imprint of personally witnessing the shooting and death of Ashley Babitt, the public humiliation by the national media and the experience of his employer's criticism publicly and nationally are heavy consequences that he has already endured and will continue to deal with for life. He also has had to deal with the financial impact of this charge over time. Our family has chosen a life of service to others — myself as a social worker committed to our underserved Latinos in Colorado, my parents as pastors and community leaders, and our older brother who once served on the local town's city council. Our family may be humble but we always try to do what is best for our communities at large by giving back. Samuel is no different. He has been compliant in his pre-trial requirements, has sought different employment and continues to be the main familial support for our aging parents. Thank you for your time and consideration of leniency on his charge.


