Defense counsel concurs in this motion. The parties request the additional time to engage in plea negotiations .

The parties request that the Court exclude the time until the status conference on February 14, 2023, pursuant to 18 U.S.C. § 3161 *et seq.*, on the basis that the ends of justice served by taking such actions outweigh the best interest of the public and the defendant in a speedy trial pursuant to the factors described in 18 U.S.C. § 3161(h)(7)(A).
