

**FINDINGS AND ORDER ON REMOVAL PROCEEDINGS

Robert Flynt Fairchild, Jr., having been arrested and presented before me for removal proceedings pursuant to Rule 5(c), Federal Rules of Criminal Procedure, and having been informed of the rights specified in Rule 5(d) thereof, and of the provisions of Rule 20, the following has occurred of record.
