MINUTE ORDER as to BENJAMEN SCOTT BURLEW: Upon consideration of the parties' joint status report, Dkt. [16], it is hereby ORDERED that (1) the parties shall appear for a video status conference on March 25, 2022, at 2:30 p.m.; and (2) time shall be excluded under the ends of justice exception to the Speedy Trial Act, 18 U.S.C. 3161, from February 4, 2022, to March 25, 2022. The parties represent that the government has produced significant amounts of discovery, including the discovery that "directly pertains to the charges against Mr. Burlew," but that its efforts to produce the entirety of the omnibus discovery in this case are ongoing. Dkt. 16 at 1-2. The parties further represent that a 60-day continuance in this matter would serve the "ends of justice," and jointly "request that the Court set a status conference for this matter in the next 60 days for the purpose of setting a trial date and motions deadline." Id. at 2. In light of these representations, and in particular the parties' ongoing efforts to complete the extensive discovery process in this case, the Court finds that the ends of justice served by the continuance outweigh the best interest of the public and the defendant in a speedy trial under 18 U.S.C. 3161(h)(7)(A). The parties should confer in advance of the March 25, 2022, status conference and should be prepared to set a motions schedule and trial date at that status conference.
