Katie was admitted to the Smith Rd. Community Residence on 7/7/99 from her home residence per referral from Cara Regan, Ph.D. affiliated with the Genesee Mental Health Center.Katie is a recently turned 15 yr.old girl who has struggled with depression over the past year. Her depression consists of crying episodes, somatic symptoms, oppositional behavior, low self esteem, and suicidal ideation without intent. Upon admission a significant problem that has resulted has been school refusal which has led to school seeking out a PINS petition, which Katie is currently under. The family and Katie have had significant stress over the years due to difficulties in the marriage which led to a separation earlier this past year. Katie has not done well with seperation, moving back and forth between both parents residence and manipulating the situation to get what she wants. Both parents have had anger toward each other that has been vented through Katie with clear triangulation of Katie contributing significantly to distress level .Due to these stress levels and Katies' ability to manipulate the situations to attempt to get what she wants and if not just refuse(i.e school) it has been recommended that a more structured environment would benefit Katie; helping provide a safe environment for her to explore her strong emotions at the same time provide consistent expectations toward school attendance and responsibilities to others. Katie was admitted to the SRCR with following diagnosis:

Axis I:Major Depressive Disorder

Parent/Child Relationship Problem

While at the SRCR Katie worked on the following treatment plan: Goal I:Katie will accept the guidelines and expectations of the SRCR program.

Obj:1a.Katie will attend school on a daily basis until completion.Katie was meeting objective for the first month and only had one more week left of summer when she refused to return from a home visit. Arrangements were made for her to finish the final week and tests at home.

Obj1b.Katie will display ownership in her treatment and awareness on her issues by meeting

with counselor one time a week and provide input into her token economy system. Katie was improving in this area where she would meet with counselor and discuss issues and seemed to be making progress on her awareness of the issues. She was able to transition well to daily house expectations.

Obj1c.Katie will identify activities of interests and pursue involvement in these activities at least one time a week.Katie has a strong interest in riding horses and working in stables.At the time she was discharge SRCR staff and Katie were pursing these interest by visiting local stables and attempting to set up a consistent schedule in these areas.

Obj1d.Katie will attend therapy on a weekly basis to identify personal issues and work on family conflicts.Katie left the program too early where her attendance and involvement in therapy was not consistent enough to make the significant progress that was needed in this case.

Katie appeared in front of family court judge in late August in which PINS were removed. Katie decided to not to return to SRCR against treatment recommendations. Over a three week period there were several meetings between Cara Regen(mental health therapist), parents and SRCR staff attempting to encourage Katie to return to SRCR without sucess. On 9/27/99 Katie was officially discharged to her mother ,Linda Morrision, 19A Wyvill ave. Scottsvile, N.Y. and the continued mental health care with Cara Regan, Genesee Mental Health.
