**UNOPPOSED MOTION TO  
CONTINUE STATUS HEARING**

COMES NOW Jodi Wilson, through counsel, and requests the unopposed continuance of the status hearing currently scheduled for October 5, 2022, and the setting of a new status date approximately three (3) weeks out. As reasons therefor, defendant states as follows:

1. This matter is currently scheduled for a status hearing before this court on October 5, 2022.
2. The parties are working towards a disposition in this matter. However, there are some issues that need to be resolved regarding the plea paperwork.
3. The parties wish for the October 3, 2022, hearing to be continued for approximately two to three weeks. In coordinating with the court, it was suggested to provide availability dates the week of October 24, 2022. The parties are available either the afternoon of October 24, 2022, or, if not, any time on October 25 or

October 26, 2022, though the afternoon would be preferred on either of those dates.

4. In addition, Ms. Wilson waives the time until the next court date to be excluded under the Speedy Trial Act.

5. Undersigned counsel has been in contact with AUSA Anita Eve and she does not oppose this motion.<sup>1</sup>

WHEREFORE, the parties jointly request for the status in this matter to be continued until some day during the week of October 24, 2022.
