**NOTICE OF DEFENDANT'S POSITION ON  
GOVERNMENT'S MOTION TO STRIKE PORTIONS OF THE INDICTMENT**

The United States of America, by and through its undersigned counsel, hereby files this Notice of defendant Cody Mattice's position on the government's Motion to Strike Portions of the Indictment. (ECF No. 36.) At the time of the government's Motion, the government had not spoken with counsel for defendant Mattice and thus was not able to obtain his position.
