MINUTE ORDER as to MEGHAN RUTLEDGE (1), WILLARD THOMAS BOSTIC, JR (2). The Court held a status hearing in this matter on December 21, 2021. Due to health concerns surrounding COVID-19 and with both Defendants' consent, the status hearing was held by videoconference. Both Defendants and their counsel, counsel for the government, and a court reporter were present by video. Both Defendants were arraigned on the charges contained in the 16 Information and both Defendants entered pleas of "not guilty" as to all counts. During the hearing, the Court discussed the government's Brady obligations, see Order, ECF No. 20, as well as the status of discovery in this matter. The government indicated that it had provided discovery as to Defendant Rutledge to her counsel, and anticipates providing discovery as to Defendant Bostic to his counsel this week. The government also indicated that it has provided access to available discovery arising from the events of January 6, 2021 to counsel for both Defendants. At the parties' request, the Court has scheduled another status hearing for MARCH 1, 2022 at 11:00 AM. Defendants have consented to this status hearing proceeding remotely via videoconference. The Court also discussed additional pretrial conditions of release as to Defendant WILLARD THOMAS BOSTIC, JR (2), which were proposed by the Pretrial Services Agency in light of the arrest in a separate case indicated in the 23 Pretrial Violation Report. Defendant Bostic agreed to these additional conditions. The Court shall adopt the additional conditions proposed by PSA in its 23 Report. During the December 21, 2021 hearing, the Court discussed with Defendants their Speedy Trial Act rights. Both Defendants consented to the exclusion of time from December 21, 2021, through the date of the next status hearing on March 1, 2022. The Court finds that a continuance of Defendants' Speedy Trial rights between December 21, 2021 and the date of the next status hearing on March 1, 2022 serves the "ends of justice" and outweighs the best interests of both the community and Defendants, in light of the ongoing COVID-19 pandemic, see Standing Order No. 21-79 (BAH) (D.D.C. Dec. 13, 2021), at 6-7 (excluding time through February 18,

2022) and because the continuance will allow Defendants to obtain discovery and review it with their counsel and to consider how they intend to proceed with the case. Taking into account this continuance, the Court has calculated that the 70-day deadline for both Defendants is: MAY 10, 2022. The Court is in receipt of the [42], [43] Motions to Continue, in which Defendants request that the Court continue the status hearing currently scheduled for May 9, 2022. Defendants seek a continuance to allow additional time for the parties to proceed with discovery and for each defendant to discuss potential pretrial resolution of the case with the government. The government does not object to the continuance requested by either defendant, and no previous continuances have been granted as to either defendant.
