In addition, for the reasons discussed in the parties' motion--namely, the need for the defendant to meet with his counsel and for the defense to determine how to best defend this case, see 18 U.S.C. § 3161(h)(7)(B)(iv)--the Court finds that the "ends of justice outweigh the best interest of the public and the defendant in a speedy trial." 18 U.S.C. § 3161(h)(7)(A). Accordingly, pursuant to the Speedy Trial Act and with the consent of the defendant, the time from January 24, 2022 through February 1, 2022 shall be excluded in computing the date for a speedy trial in this case.
