**Motion to Modify Conditions of Release to Allow Contact with Mr.
Beddingfield's Father on December 24, 2022.**

Matthew Beddingfield by and through Counsel, hereby moves the Court for a modification of his conditions of release to allow him to travel to the Washington D.C. area on Monday, July 10, 2023. In support of this motion, Mr. Beddingfield states the following:

1. A sentencing hearing is currently scheduled for July 11, 2023 at 11:30AM.
2. Mr. Beddingfield is on conditions of release that include a curfew and GPS monitoring. He is located about 4.5 hours away from the Court without traffic. Mr. Beddingfield is concerned about unforeseeable issues preventing him from being timely to his Sentencing Hearing.
3. Mr. Beddingfield needs to travel to the Washington D.C. on Monday, July 10, 2023 to avoid any problems preventing his timely appearance in Court.
4. Mr. Beddingfield has a reservation at the Comfort Inn in Alexandria, VA on July 10, 2023.

5. The assistant United States Attorney assigned to prosecute Mr.

Beddingfield, Sean Murphy, has been contacted about this motion and he does not object to this filing.

WHEREFORE, Mr. Beddingfield respectfully requests that he be permitted to travel from his home in Bailey, North Carolina to the Washington D.C. metropolitan area on July 10, 2023, and stay in the Comfort Inn in Alexandria, VA.
