GOV'T NOTICE OF FILING OF VIDEO EXHIBITS PURSUANT TO LCrR 49

Pursuant to LCrR 49(e)(1) and Standing Order No. 21-28 (BAH), the government and hereby gives notice of the following video exhibits in support of its sentencing memorandum (ECF No.XX). These videos have been provided to the Court and all counsel via a secure filesharing platform. Due to the length of some videos, the parties recommend that the Court and Counsel review them prior to the hearing so that insofar as is possible and if desired, the parties may incorporate the exhibits by reference at the sentencing hearing. Should the Court or Counsel request, however, the parties will be ready to show any video in its entirety at the hearing.

At this time, the parties have no objection to the public release of these videos.

Description: The video shows Beddingfield walking towards the Maryland Walkway at approx. 00 min 10 sec.

Description: Rioters breach the police line at the Maryland Walkway. Beddingfield is visible at approx. 01 min 24 sec. A person near the videographer shouts disapproval. Shortly after Beddingfield is seen, a police officer may be heard shouting: Anyone going up here is subject to arrest!

Description: Another rioter recorded this video as they walked up the Maryland Walkway. Beddingfield is first visible at approx. 01 min 03 sec. As the videographer gets closer to Beddingfield, a police officer yells at Beddingfield, "Hey, get out of here!" Beddingfield looks back at the police officer and then walks in the opposite direction that the police officer is pointing. Beddingfield may be heard shouting:

No tyranny is here! No tyrants here! Go, go, go! Get the fuck outta here! This is America, no tyrants here! No tyrants here! No tyrants here! No tyrants here! Get the fuck outta here! [repeating]

Description: At approx. 00 min 08 sec, Beddingfield jumps over the metal fence and rushes the West Plaza.

Description: A USCP Officer recorded video of the rioters as they overtook the West Plaza. This one video is a compilation of five independent videos. Beddingfield is seen at approx. 01 min 44 sec making his way towards the front of the line. He engages in violent conduct with the police officers. At approx. 03 min 28 sec, a voice is heard stating, "He's hitting him with the flag! [unintelligible] He's using the flag as a spear! He's in a grey shirt, grey top, grey hat." Beddingfield's father may also be seen in the crowd, including at 04 min 15 sec. At approx. 06 min 57 sec, Beddingfield may again be seen advancing towards several police officers and jabbing with his flagpole and kicking into the scrum.

Description: These videos were recorded by another defendant. The screenshot below is from EXHIBIT 06c at approx. 00 min 57 sec and shows Beddingfield holding both his flag and the broken piece that he would later throw at the police line.
