Defendant Luke Lints, through undersigned counsel, respectfully submits the following objections to the Draft Presentence Investigation Report (April 21, 2023) [ECF No. 46] (the "Draft PSR").

**Paragraphs 33-37:** Paragraphs 33-37 of the Draft PSR state that on January 6, 2021, Mr. Lints "engage[d]" in a violent assault against multiple law enforcement officers." Draft PSR ¶134. Mr. Lints has not been charged with assaulting a law enforcement officer (18 U.S.C. §111), and did not assault any law enforcement officer on January 6, 2021.
