**GOVERNMENT’S NOTICE OF FILING OF EXHIBITS PURSUANT  
TO LOCAL CRIMINAL RULE 49 AND STANDING ORDER 21-28**

The United States hereby gives notice, pursuant to Local Criminal Rule 49 and Standing Order 21-28, of the following exhibits provided to the Court (via USB Hard Drive) and defense counsel (via USAFcx) to be used by the government in the sentencing in this matter. The exhibits are categorized by source, and are as follows:

1. Government’s Exhibits A-1 through A-11 are short videos taken on January 6, 2021, from Ferreira’s phone. They are not timestamped. The videos document her approach to the Capitol building (A-1, A-2, A-3), presence on Capitol grounds (A-4, A-5, A-6), entry into the Capitol through the Senate Wing Door (A-7), approach of a staircase as she exits the Crypt (A-8), presence in the Rotunda (A-9) and East Rotunda Lobby (A-10), and what appears to be a video taken as she exits the Senate Wing Door (A-11).

2. Government’s Exhibits B-1 through B-4 are open source videos. Video Exhibits B-1\_A through B-1\_E are snippets recorded from a lengthy YouTube video downloaded from [https://www.youtube.com/watch?v=\\_E-6bRNfx2c&t=1022](https://www.youtube.com/watch?v=_E-6bRNfx2c&t=1022). Each Exhibit B-1\_A through B-1\_E is identified with a time identifying when Ferreira is observed in the video. Government’s Exhibit B-2 is a video from Parler downloaded from

p4. Government's Exhibits B-3 and B-4 are open source videos from unknown individuals taken while inside the Capitol on January 6, 2021.

3. Government's Exhibit C-1 through C-4 are CCTV videos. Exhibit C-1 shows Ferreira entering through the Senate Wing Door. Exhibit C-2 shows Ferreira in the Crypt. Exhibits C-3 and C-4 show the East Rotunda Lobby from different angles.

4. Government's Exhibit D is Ferreira's post-arrest statement to the FBI.
