I am Stacy Bond's younger brother. I can attest to Stacy's character, as I have lived close with him over the course of my lifetime and am privy to intimate details of his life.

Stacy's has experienced serious trauma over the course of his life, but more recently several events are contributing to his current state of mind. Stacy's eldest son, Eric, passed away in a car accident about eight years ago. His youngest and only remaining child, Cody, passed away of a fentanyl overdose about five years ago. On Christmas day 2020, his nephew Daniel Jr. passed away of a fentanyl overdose followed by the suicide of his older brother, Daniel Sr, about a month later. Stacy was particularly close with Daniel Jr. and Daniel Sr. since his sons passed, as they worked together for Stacy's construction business.

Before Daniel Sr. passed away, Daniel was struggling with alcoholism. Stacy sacrificed much of his personal time to help him work the program, as he has also done for countless others as part of the AA community. With Stacy's support, Daniel Sr. had maintained sobriety for the last five years, until his son passed away.

On top of the challenges posed by the above are the added disruption of COVID-19, the political polarization and manipulation by certain news outlets and political leaders. I believe he was searching for stable ground after enduring such hardships and fell victim to conspiracy theories that led to his actions.

As far as my relationship with Stacy, in recent years I have seen him demonstrate a commitment to helping others, even as he has struggled to heal himself.

Dear Mr. Fay:

My name is Brian Stull and I am writing to you on behalf of Stacy Bond. I have known Mr. Bond for approximately 6-7 years via a mutual friend. Over the past 15 months or so I have come to know him better while assisting him with home repairs. We do not see eye to eye on many of his political beliefs or media consumption, however, I know him to be a kind and reasonable man. I know that Stacy has been going through some tough times these past 2 years after experiencing the loss of his son, his brother, and his nephew, as well as some rough times due to the Covid-19 lockdowns. In that time he has always kept his head up and never looked to blame anyone else for the hardships that he went through. He did his best to keep his employees working and paid during the lockdowns and recent financial hardships that most are dealing with. During the many times that I have witnessed him engaging in or engaged with him in the discussion of political matters, he has expressed his grievances with a multitude of actions taken by opposing parties or with certain political ideologies in general. I cannot recalled over the course of those discussions any statements made by Stacy that directly or indirectly called for any violence against any person or party. I have never heard him speak about the need to overthrow or impede the government from doing its job and I do not believe that Stacy would have been present at the January  $6^{th}$  rally had he known that the events would end up the way they did that day. Now, I do not know the extent of his actions on that day. I was not even aware he had attended the rally until a few weeks later, nor that he was in any legal trouble until his arrest just a few months ago. I do however feel that violence and unrest were not his intentions and that he merely went down that day to exercise his 1st amendment right, even though I believe there was nothing to protest and that he was being intentionally misled by the FPOTUS. While I do believe that the people who organized the events that unfolded that day, the people who mislead and provoked the attendees for their own personal benefit, and those that engaged in violence and/or vandalism should be brought to justice, I do not know Stacy to be the kind of man who would risk his freedom, life and livelihood to engage in such actions.
